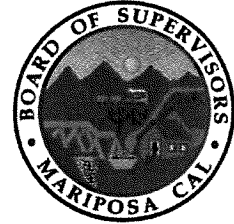

### RECOMMENDATION AND JUSTIFICATION:

Approve the Mariposa County Fire Department Assistance by Hire Agreement with the Madera-Mariposa-Merced Unit (MMU) of CAL FIRE; and Authorize the Board of Supervisors Chair to Sign the Agreement.

MMU desires to have local agreements that provide for Assistance by Hire (ABH) utilization of Mariposa County firefighting resources to augment CAL FIRE resources in support of the State's mission within the State Responsibility Areas (SRA) of MMU when the need arises.

The current ABH with MMU was approved on December 18, 2007, and is in need of updating. The new ABH will be in line with the current California Office of Emergency Services (Cal OES) rates and standards as set by the California Fire Assistance Agreement (CFAA).

### BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board of Supervisors has approved an Assistance by Hire Agreement with MMU in the past.

### ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Mariposa County will continue to lose reimbursement from resources supporting the State mission in the SRA of MMU.

### FINANCIAL IMPACT:

**This ABH agreement will increase the amount of revenue Mariposa County receives from CAL FIRE when County Fire resources are hired to support the State mission in the SRA of MMU.**
