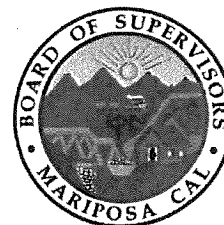

RE: Legal Services Agreement with Wanger, Jones, Helsley, PC

RECOMMENDATION AND JUSTIFICATION:

Approve a Legal Services Agreement with Wanger, Jones, Helsley, PC to Provide Legal Services to the County of Mariposa; and Authorize the Board of Supervisors Chair to Sign the Agreement.

This Agreement retains Wanger, Jones, Helsley, PC to represent Mariposa County in a legal action filed by Jeffrey Brown in the United States District Court.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On December 29, 2017 Jeffrey Brown filed a claim for personal injury. The claim was rejected by the Board of Supervisors on February 12, 2018.

On November 8, 2018 a Complaint for personal injuries and damages was filed with the United States District Court and served on the County and separately named and served was the Sheriff's Department and John C. Fremont Healthcare District.

The funding for this agreement will be paid from the County's Liability fund and there is currently sufficient money in this fund for this Legal Services Agreement.

Dear Mr. Dahlem:

Thank you for asking our firm to represent the County of Mariposa defendants in connection with the Jeffrey Brown matter. Consistent with our ethical and professional responsibilities, this letter will confirm the terms of this representation.

The value of our services is based upon actual time spent by the attorneys and legal assistants working on your representation. We charge for our time in minimum units of one-tenth of an hour. All attorneys of the firm are assigned hourly rates. At present, the attorneys' rates range from \$180 to \$495 per hour. My hourly fee for this representation will be \$395. The hourly rate for law clerks and paralegals is presently \$140

to \$180 per hour. We reserve the right to increase this hourly rate at any time during the course of our representation upon written notice.

We attempt to serve our clients with the most effective support systems available while at the same time allocating the costs of these systems in accordance with the extent of usage by individual clients. Therefore, in addition to our fees for legal services, we also charge separately for certain cost and expense disbursements as described in the attached schedule. Large disbursement billings may be forwarded to you for direct payment.

Any estimates of anticipated fees which we provide, whether for budgeting purposes or otherwise, are necessarily only an approximation of potential fees. Actual fees are determined in accordance with the policies outlined above and are often the result of factors beyond our control, e.g., the actions of adverse parties or their attorneys.

Our representation is a matter of mutual consent. Accordingly, you may discharge us at any time and we may withdraw from this representation with your consent or for good cause. Good cause includes breach of the terms of this agreement (including failure to pay all billing statements when due), your refusal to cooperate with us or to follow our advice on a material matter, or any other fact or circumstance which would render our continuing representation impractical, unlawful or unethical.

When our services conclude for whatever reason, all unpaid charges will become immediately due and payable. After our services conclude, we will, upon your request, deliver your file to you along with any of your property or any balance of your funds in our possession.

We bill monthly. We expect payment within thirty (30) days of receipt of our billing. Outstanding bills not paid within sixty (60) days may be charged monthly interest at the rate of 8 percent per annum or .667% per month.

While I will be the attorney primarily responsible for your representation, I may, if I believe it necessary, have other attorneys or paralegals participate in representing your

interests. Although we represent our clients within the bounds of ethics and the law, we cannot guarantee the successful conclusion of any legal matter or the favorable outcome of any legal action.


We maintain errors and omissions insurance which is in excess of the limits which are required by the State Bar for matters of this type.
