RE: First Amendment - Agreement with Shaun Quinn to Provide MH Triage Services

---

### RECOMMENDATION AND JUSTIFICATION:

Approve a First Amendment to the agreement with Shaun Quinn to provide Mental Health Triage Services, increasing the amount by \$25,000 to a new amount not to exceed \$60,000; and authorize the Board of Supervisors Chair to sign the amendment.

The triage contractor will provide mental health triage response for individuals in the hospital, the jail, and in the field when the Sheriff's department requests a triage worker to respond with them. The triage worker will determine if a community member qualifies for a psychiatric assessment or whether there are resources from family members, a friend or other community individuals that can provide support so the individual can remain in his/her home.

The Mental Health Triage Contractors provide after-hours and weekend 24 hour services to clients in a mental health crisis. During this agreement period, more work has been required from Shaun Quinn than anticipated.

### BACKGROUND AND HISTORY OF BOARD ACTIONS:

The existing agreement with Shaun Quinn was approved on June 6, 2018 by the County Administrative Officer.

### ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If this Amendment is not approved, the Department may be unable to adequately serve after-hours and weekend mental health crisis needs of county residents.

### FINANCIAL IMPACT:

**These contract expenses are budgeted in the Mental Health fund 001-0402 for Fiscal Year 2018-19. There is no impact to the County General Fund.**

**FIRST AMENDMENT TO AGREEMENT FOR TRIAGE SERVICES**

**THIS FIRST AMENDMENT TO AGREEMENT FOR TRIAGE SERVICES** is made and entered into this 7<sup>th</sup> day of May 2019, by and between the County of Mariposa, a political subdivision of the State of California hereinafter referred to as “**County**,” and Shaun Quinn hereinafter referred to as “**Contractor**.”

**WHEREAS**, **County** and **Contractor** have heretofore entered into an Agreement dated June 6, 2018, wherein **Contractor** agreed to provide triage services; and

**Whereas**, **County** and **Contractor** desire to amend said Agreement to change the compensation to be provided to **Contractor**;


**NOW THEREFORE**, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph 3, “COMPENSATION”, is hereby amended to provide that an additional \$25,000 will be added to the original amount of \$35,000, making the total compensation paid to **Contractor** not to exceed amount of \$60,000.

2. Except as herein amended, the Agreement dated June 6, 2018 shall remain in full force and effect.
