RE: Approve the First Amendment to the 2017-2018 Agreement with Forensic Pathology Services

### RECOMMENDATION AND JUSTIFICATION:

Approve the First Amendment to FY 2017-2018 Professional Service Agreement with Forensic Pathology Services for Post Mortem examinations and autopsies of deceased persons, increasing the Amount by \$20,000.00; and Authorize the Board of Supervisors Chair to Sign the Amendment.

The Mariposa County Board of Supervisors approved Resolution 2017-302 and it became effective on July 1, 2017 and expired on June 30, 2018, in a not to exceed amount of \$70,000. Due to unanticipated demands for services within Mariposa County the contracted amount has been exhausted. The additional \$20,000.00 is needed to support contractual costs incurred during the end month of June, 2018. Appropriations to support this increase for the Agreement have already been allocated in the approved Fiscal Year 2017-2018 Sheriff Budget.

### BACKGROUND AND HISTORY OF BOARD ACTIONS:

Mariposa County has entered into an Agreement with Forensic Pathology Services since 2007.

**ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:** Forgo the Amendment and Mariposa County will have to find other means of meeting our obligations.

### FINANCIAL IMPACT:

There will be no Financial Impact as appropriations have been allocated in the Approved 2017/2018 budget.

**FIRST AMENDMENT TO AGREEMENT FOR FORENSIC PATHOLOGY SERVICES**

**THIS FIRST AMENDMENT TO AGREEMENT FOR FORENSIC PATHOLOGY SERVICES** is made and entered into this 13<sup>th</sup> day of June, 2018, by and between the County of Mariposa, a political subdivision of the State of California, hereinafter referred to as "**County**", and Stanislaus County, hereinafter referred to as "**Contractor**".

**WHEREAS, County and Contractor** have heretofore entered into an Agreement dated July 1, 2017, wherein **Contractor** agreed to provide Forensic Pathology services; and

**WHEREAS, County and Contractor** desire to amend said Agreement to change the compensation to be provided to **Contractor** due to unanticipated demands for services.

**NOW, THEREFORE,** the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph 4.01, "COMPENSATION", is hereby amended to provide that an additional \$20,000.00 will be added to the original amount of \$70,000.00, making the total compensation paid to **Contractor** the not to exceed amount of \$90,000.00.

2. Except as herein amended, the agreement dated June 13<sup>th</sup>, 2018 shall remain in full force and effect.


