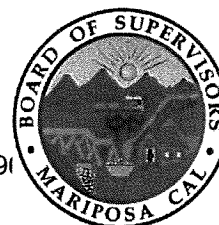

RE: Second Amendment to Agreement with Dobbins Transportation

RECOMMENDATION AND JUSTIFICATION:

Approve Second Amendment to Agreement with Dobbins Transportation, Inc. to provide transportation services for Mariposa County Health and Human Services Agency, increasing the amount by \$10,000 for a new amount not to exceed \$60,000; and authorize the Board of Supervisors Chair to sign the Amendment.

Dobbins Transportation operates a non-emergency medical transportation service located in Atwater, California. Dobbins provides a 24-hour on-call response to Mariposa County Health and Human Services Agency requests for client transports. During the current agreement period, usage for this service has proven to be greater than anticipated and resulted in the need for additional amendments to increase the agreement amount.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The County Administrative Officer approved the current agreement on June 18, 2018 and First Amendment to the current agreement on November 28, 2018.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If this amendment is not approved, Health and Human Services will be hindered in providing necessary non-emergency medical transportation for Mariposa County clients.

FINANCIAL IMPACT:

This contract will be paid within the Mental Health budget units. There will be no impact to the County General Fund.

SECOND AMENDMENT TO AGREEMENT FOR TRANSPORTATION SERVICES

THIS SECOND AMENDMENT TO AGREEMENT FOR TRANSPORTATION SERVICES is made and entered into this 23rd day of July 2019, by and between the County of Mariposa, a political subdivision of the State of California hereinafter referred to as **“County,”** and Dobbins Transportation, Inc. hereinafter referred to as **“Contractor.”**

WHEREAS, County and Contractor have heretofore entered into an Agreement dated June 18, 2018, wherein **Contractor** agreed to provide transportation services; and

Whereas, County and Contractor have heretofore entered into a First Amendment dated November 28, 2018, wherein the compensation was increased from \$20,000 to \$50,000; and

Whereas, County and Contractor desire to amend said Agreement to change the compensation to be provided to **Contractor**;


NOW THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph 3, “COMPENSATION”, is hereby amended to provide that an additional \$10,000 will be added to the amended amount of \$50,000, making the total compensation paid to the **Contractor** not to exceed amount of \$60,000.

2. Except as herein amended, the Agreement dated June 18, 2018 shall remain in full force and effect.
