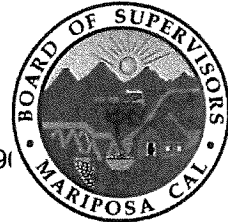

RESOLUTION - ACTION REQUESTED 2019-470

MEETING: August 13, 2019

TO: The Board of Supervisors

FROM: Chevon Kothari, Health and Human Services Director

RE: Second Amendment - Quest Community Counseling Mental Health Provider Contract

RECOMMENDATION AND JUSTIFICATION:

Approve a second amendment to the agreement with Quest Community Counseling Services, increasing the maximum amount by \$60,000 for a new amount not to exceed \$220,000; and authorize the Board of Supervisors Chair to sign the amendment.

The client demand for this contractor's services have exceeded projections. The Agreement costs are offset by Medi-Cal revenue claimed for services performed. This agreement is cost neutral to the County and there is no impact to the County General Fund. Quest Community Counseling Services is a Medi-Cal certified provider and may provide counseling services to clients that have Medicare, Medi-Cal, and/or private insurance.

Medi-Cal clients referred to this contractor may be seen as long as necessary for the purpose of stabilization. Clients seen over a period of time must continue to meet medical necessity as evidenced by a yearly treatment plan update. All records for these referred clients must be kept in the Mariposa County Behavioral Health Anasazi Electronic Health Record (EHR) system. Case documentation that meets professional standards must be kept in the Anasazi system, including acceptable updated assessments, treatment plans and progress notes. Documentation will be monitored by the Behavioral Health Utilization Review Committee. All independent contractors will work under the guidelines established by the Mental Health Services Contract currently in effect between the Health and Human Services Agency and the State Department of Mental Health as outlined in Exhibit A of the contract.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The current agreement for this facility was approved by the Board on July 17, 2018, by Resolution Number 2018-346.

First amendment to current agreement was approved by Board on March 26, 2019, by Resolution Number 2019-156.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If the amendment is not approved, we may have longer wait times for clients to be served.

FINANCIAL IMPACT:

This contract will continue to be paid within the Mental Health budget unit. Contract costs are offset by Medi-Cal revenue claimed for services performed. This contract is cost neutral to the County and there is no impact to the County General Fund.

SECOND AMENDMENT TO AGREEMENT FOR COUNSELING SERVICES

THIS SECOND AMENDMENT TO AGREEMENT FOR COUNSELING SERVICES is made and entered into this 13th day of August 2019, by and between the County of Mariposa, a political subdivision of the State of California hereinafter referred to as "County," and Quest Community Counseling Services, hereinafter referred to as "Contractor."

WHEREAS, County and Contractor have heretofore entered into an Agreement dated July 17, 2018, wherein **Contractor** agreed to provide counseling services; and

WHEREAS, County and Contractor have heretofore entered into a First Amendment dated March 26, 2019, wherein the compensation was increased from \$100,000 to \$160,000; and

WHEREAS, County and Contractor desire to amend said Agreement to change the compensation to be provided to **Contractor**.


NOW THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph 3, "COMPENSATION", is hereby amended to provide that an additional \$60,000 will be added to the amended amount of \$160,000, making the total compensation paid to **Contractor** the not to exceed amount of \$220,000.


2. Except as herein amended, the Agreement dated July 17, 2018, together with the First Amendment dated March 26, 2019, shall remain in full force and effect.
