RE: Amendment 17-94082 A02 to Substance Abuse 2017-2020 Contract with DHCS

RECOMMENDATION AND JUSTIFICATION:

Approve Amendment 17-94082 A02 to the Current Substance Abuse 2017-2020 Multi-Year Agreement with the State Department of Health Care Services (DHCS), and Authorize the Board of Supervisors Chair to Sign the Amendment.

A copy of the full initial agreement is on file in the Clerk of the Board's Office. Amendment 17-94082 A02: 1) increases the funding allocation for Fiscal Year 2019-20 by \$47,500, and 2) Paragraph 4 (incorporated exhibits) on the face of the original STD 213 is amended to add a revised Budget Exhibit: Exhibit B, Attachment I A2.

Certain changes made in this amendment are shown as: Text additions are displayed in bold and underline. Text deletions are displayed as strike through text (i.e., ~~Strike~~).

This Agreement provides the authorization and revenue to operate the County's substance abuse prevention and treatment services. The Agreement sets forth the terms and conditions under which the services must be provided.

This Agreement is subject to ongoing amendments by the State. Funding to provide County Alcohol and Drug services is contingent upon approval of this Agreement and subsequent amendments issued by DHCS.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board approved the existing multi-year Agreement 17-94082 with the State Department of Health Care Services (DHCS) on October 3, 2017 by resolution 2017-670.

The Board approved Amendment 17-94082 A01 on March, 26 2019 by resolution 2019-155.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If this contract is not approved, DHCS will discontinue funding for county alcohol and substance abuse programs.


