RE: First Amendment - Burney Stephens Agreement to Provide Dental Hygienist Services

RECOMMENDATION AND JUSTIFICATION:

Approve First Amendment to Agreement with Burney Stephens, RDH to provide dental hygienist services, increasing the amount of the agreement by \$10,140 to a new amount not to exceed \$50,700; and authorize the Board of Supervisors Chair to sign the Amendment.

Burney Stephens is a Registered Dental Hygienist (RDH) with a counseling office in Mariposa. With Health and Human Services Agency (HHSA) staff, she implements the Mariposa County Oral Health program by building capacity and engaging stakeholders in education of the community about the importance of dental health. The amount of required services for the agreement proved to be greater than anticipated, resulting in the requested amendment.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Board of Supervisors has no history with the Contractor. The existing agreement was approved by County Administrative Officer on February 29, 2019.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If the amendment is not approved, HHSA would have significant difficulty in providing necessary services to County residents.

FINANCIAL IMPACT:

The costs of this agreement is funded by Oral Health grant funds. There is no anticipated current or future impact to the County General Fund.

FIRST AMENDMENT TO AGREEMENT FOR DENTAL HYGIENIST SERVICES

THIS FIRST AMENDMENT TO AGREEMENT FOR DENTAL HYGIENIST SERVICES is made and entered into this 17 day of December 2019, by and between the County of Mariposa, a political subdivision of the State of California hereinafter referred to as “**County**,” and Burney Stephens, RDH, hereinafter referred to as “**Contractor**.”

WHEREAS, County and Contractor have heretofore entered into an Agreement dated February 28, 2019, wherein **Contractor** agreed to provide dental hygienist services; and

Whereas, County and Contractor desire to amend said Agreement to change the compensation to be provided to **Contractor**;

NOW THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph 3, “COMPENSATION”, is hereby amended to provide that an additional \$10,140 will be added to the original amount of \$40,560, making the total compensation paid to **Contractor** the not to exceed amount of \$50,700.

2. Except as herein amended, the Agreement dated February 28, 2019 shall remain in full force and effect.
