The Mariposa County 2021 Recreation and Resiliency Master Plan is a 20-year vision that sets the direction for the County as a resiliency leader and a great place to live and recreate. The plan articulates the role of Mariposa County's recreation infrastructure in supporting community-wide health and resilience and provides a strategy for how future investments can participate in, or even lead, that effort. Specifically, the plan articulates community recreation needs and devises a strategy for developing and maintaining new and existing parks, open spaces, trails, and other recreation amenities. The plan also applies a resiliency framework to identify opportunities for investments to support climate change adaptation and mitigation.

This plan was developed using an extensive stakeholder engagement process to understand the community's needs for current and future park and recreation programming, and preferences for park and recreation aesthetics and character.

At the hearing, the Board of Supervisors will consider adopting a resolution approving the Recreation and Resiliency Master Plan, finding the project is exempt from CEQA, and authorizing county departments and agencies to pursue implementing its recommendations. **The draft plan is available for public review on-line at <http://www.mariposacounty.org/80/Planning> (click on "Current Projects")**
