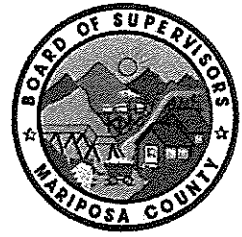

RE: Final Response to 2020-21 Grand Jury Report

RECOMMENDATION AND JUSTIFICATION:

Approve the Response of the Board of Supervisors to the 2020-2021 Mariposa County Grand Jury Final Report; Authorize the Board of Supervisors Chair to Sign the Response; and Direct the County Administrative Officer to Transmit the Response to the Presiding Judge of the Mariposa County Superior Court.

The California Penal Code requires the Board of Supervisors, as the governing body of a public agency subject to the Grand Jury's reviewing authority, to comment to the Presiding Judge of the Superior Court on the findings and recommendations pertaining to the matters under the control of the governing body within ninety days after the Grand Jury submits its Final Report.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On October 6, 2020, the Board approved Resolution 20-585, a response to the 2019-20 Grand Jury Final Report.

On February 18, 2020, the Board approved Resolution 20-75, a response to the 2019-20 Grand Jury Interim Report.

On August 20, 2019, the Board approved Resolution 19-480, a response to the 2018-19 Grand Jury Final Report.

On September 11, 2018, the Board approved Resolution 18-432, a response to the 2017-18 Grand Jury Final Report.

On September 12, 2017, the Board approved Resolution 17-615, a response to the 2016-17 Grand Jury Final Report.

On August 9, 2016, the Board approved Resolution 16-429, a response to the 2015-16 Grand Jury Final Report.

On November 3, 2015, the Board approved Resolution 15-521, a response to the 2014-

15 Grand Jury Final Report.

The Board has responded to earlier grand jury reports as required.
