RECOMMENDED ACTION AND JUSTIFICATION: Approve the temporary closure of the south bound lane on Jones Street and north bound lane on Bullion Street and the closure of 13th and 12th between Jones and Bullion Street to create a safety lanes during Halloween Trick or Treating activity.

The Mariposa County Sheriff's Office is requesting the Board of Supervisors approve the placement of traffic safety cones on the center line of Jones and Bullion Street; closing off one traffic lane and to create a temporary one-way traffic flow on Jones and Bullion Street and the closure of 12th and 13th Streets to create a safety lanes for pedestrians during Halloween, for Trick or Treating activities on October 31, 2011. The road closure will not affect access to residential areas.

Attached is the application for encroachment permit and map.

The temporary closure will be from 5:30 PM to 10:00 PM. The placement and removal of traffic safety cones will be the responsibility of the Mariposa County Sheriff's Office. All intersections that are closed will be staffed by Sheriff's Office personnel to assist drivers.

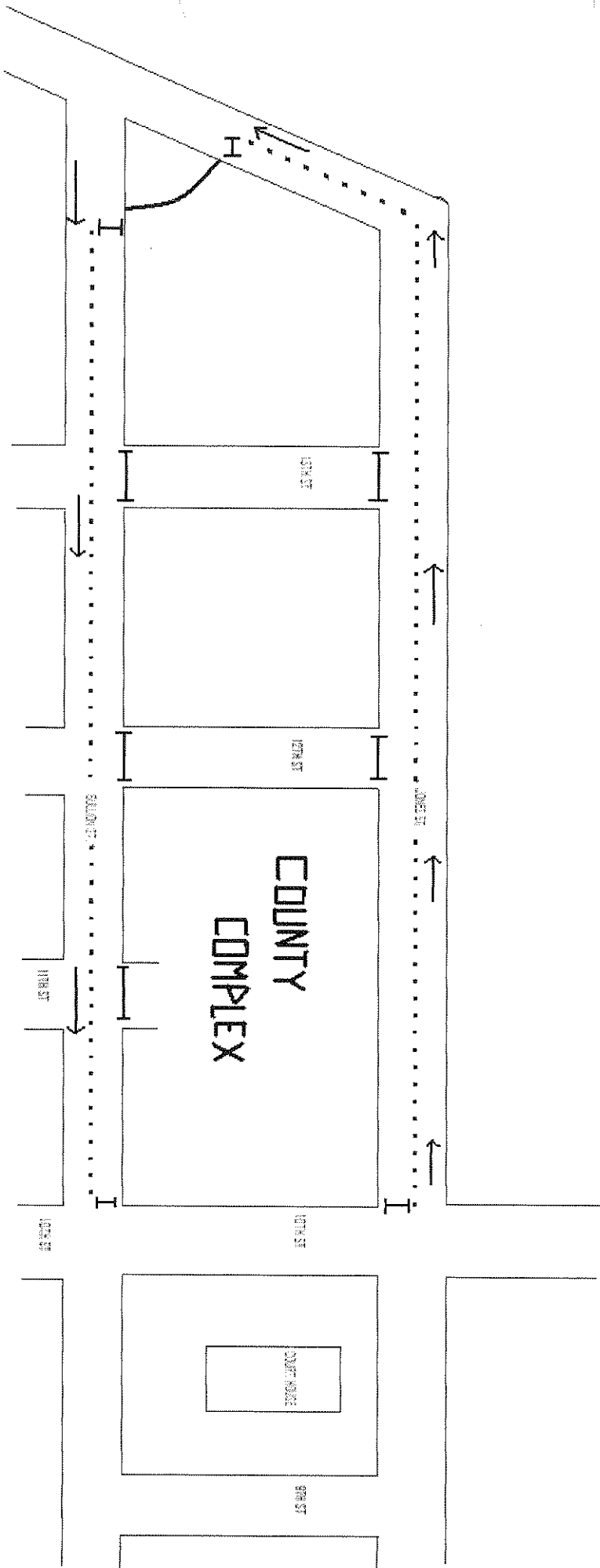
