RECOMMENDED ACTION AND JUSTIFICATION:

Approve Mariposa Public Works (MCPW) Solid Waste & Recycling Division's request to accept \$9,400 from CalRecycle Farm and Ranch Solid Waste Cleanup and Abatement Grant into their budget. This grant is designed to assist eligible applicants to pay for designated costs of cleanup, abatement, or other remedial actions related to the disposal of illegal solid waste on farm or ranch property.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board of Supervisors has always promoted responsible solid waste management in Mariposa County.

In January 2009, the Board of Supervisors approved applying for this grant on behalf of a Mariposa County property owner. Approximately \$9,000 will be transferred to the property owner to cover cost of cleanup.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If the Board does not approve this action then the funds will revert back to CalRecycle. Currently the County has no funding to assist in disposal costs of illegal dump sites on ranch or farm land.


