Recommendation

It is respectfully requested that your Board approve and authorized the Board Chair to sign the attached purchase agreement for the new Human Services Department Family Services Center.

Background/Current Situation

In November 2009 your Board approved and signed a 25 year lease with DesCor for the new Human Services facility (Res. 09-563). Contained in that agreement is an option to purchase the Family Services Center using Mental Health Services Act Capital Project funding. The Department has received State approval and funding for this purchase and is now requesting approval to exercise that option.

Attached are the necessary documents for signature that have been approved by County Counsel and the State documents approving the use of funds.

Financial

The final purchase price for the Family Services Center is \$967,500. This purchase is fully funded by State grant and there is no impact on the general fund.
