**RECOMMENDED ACTION AND JUSTIFICATION:**

Approve the Annual Catheys Valley Volunteer Fire Department's Bar-B-Cue as a County sponsored event for insurance purposes. On June 18, 2006, the Catheys Valley Volunteer Fire Department will be holding its annual fund raising bar-b-cue at McKay Hall. Money raised from this event is used to help offset County funds to purchase fire suppression equipment and station equipment, and is used for facility repairs and improvements. There is no alcohol served or provided at this event.

If the Board approves this as a county sponsored event, then the Annual Catheys Valley Volunteer Fire Department's Bar-B-Cue will be listed as an additional insured on the County's insurance liability rider. There is no cost to the county for this rider.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The Board has approved other community events as county sponsored events for insurance purposes.

**ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

Do not approve the Annual Catheys Valley Volunteer Fire Department's Bar-B-Cue as a county sponsored event. The event will need to purchase insurance through the County, which will reduce the amount of money raised by the bar-b-cue.
