**RECOMMENDED ACTION AND JUSTIFICATION:** Approve agreement and authorize Chairman of the Board of Supervisors to sign an interim Rental Agreement with 35-A District Agricultural Association for use of the fairgrounds facility for calendar year 2006. Utilization of the fairgrounds facility shall be limited to trainings, meetings and other similar events and/or activities.

The 35-A District Agricultural Association is requesting approval of an Interim Rental Agreement for the use of the fairgrounds facility, which is located at 5007 Fairgrounds Road. The rental agreement will allow the Mariposa County Sheriff's Office to utilize the designated facilities during the 2006 calendar year at no cost to the sheriff's office or Mariposa County. The facility shall be utilized for the purpose of holding trainings, meetings and other events and/or activities as approved by General Manager Bullis and Sheriff Allen.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:** The Board has signed all previous Interim Rental Agreements between the sheriff's Office and 35-A District Agricultural Association for use of the fairgrounds.

**ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:** Failure to authorize the agreement will result in an alternate location being utilized for training and meeting purposes. The use of an alternate site may result in the sheriff's office having to pay for the use of other facilities.
