RECOMMENDED ACTION AND JUSTIFICATION:

AUTHORIZED THE COUNTY LIBRARIAN TO ACCEPT THE COMPUTER DONATIONS FROM THE FRIENDS OF THE LIBRARY OF MARIPOSA, RED CLOUD, WAWONA.

The San Joaquin Valley Library System (SJVLS) requires that networked PCs be replaced on a four year cycle. This was a recommendation of Information Systems Consultants, Inc. and was adopted in principle by the SJVLS Administrative Council on 6/28/2000. Although at that time a 3 year replacement cycle was the industry standard, the SJVLS replacement cycle was set at 4 years in recognition of the budgetary limitation faced by public libraries. The Mariposa County Library System needs to replace some of its computers and the Friends of the Library for Mariposa, Red Cloud, and Wawona have graciously offered to donate the computers. The dues that the Mariposa County Library System contributes to the SJVLS consortium will also help to purchase the computers.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board of Supervisors has authorized the County Librarian to accept other donations.
