RE: Authorize Resubmission of California Emergency Management Agency
Form 130

RECOMMENDATION AND JUSTIFICATION:

Approve the California Emergency Management Agency, Form 130; Applicants Agent Resolution for Non-State Agencies, and Authorize the Required Signatures on the Form 130. This form allows for a universal resolution designating specific County staff to file for emergency financial assistance and is effective for all open and future disasters up to 3 years following the date of this approval. This is required by CalEMA for any grant funding for financial assistance after a disaster; obtaining Federal financial assistance under Public Law 93-288 as amended by Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Mariposa County seeks financial recovery funds when a declared or significant disaster impacts communities or the County as a whole. The two most common forms of public assistance are Fire Management Assistance Grant (FMAG) and the California Disaster Assistance Act Fund (CDAA.) Both of these public assistance programs require the governing body of the County from which the request originates to have a current CalEMA 130 form on file.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:


Forego an opportunity to recover from financial impacts created by declared or significant disasters.
