A RESOLUTION RECOGNIZING LEE STETSON FOR HIS
OUTSTANDING SERVICE TO THE COUNTY OF MARIPOSA**

WHEREAS, LEE STETSON was elected to the Mariposa County Board of Supervisors in June of 2010 and took office in January of 2011, for his second non-consecutive term, and served as Chair in 2013; and

WHEREAS, LEE served as Chair of the Local Transportation Commission, Local Agency Formation Commission (LAFCo) and President of the Mariposa County Public Financing Corporation; and

WHEREAS, LEE served the County on the following committees: Disaster Advisory Council, El Portal Town Planning Advisory Committee, Local Transportation Commission Technical Advisory Committee, Midpines Community Advisory Board, Yosemite West Planning Advisory Committee, and Yosemite West Maintenance District Advisory Committee; and

WHEREAS, LEE served the County on the following agencies: Yosemite Area Regional Transportation System (YARTS), and the San Joaquin Valley Rail Committee; and

WHEREAS, LEE served as Board liaison member to the Development Services, the Justice System Services, the Health and Human Services areas and Yosemite Park issues; and

WHEREAS, LEE tirelessly worked on issues pertaining to the following County projects: the acquisition of additional land for the expansion of the Midpines Community Park, funding and construction of four new fire stations, the CSA 3 Fire Assessment, road maintenance projects, General Plan/Zoning Amendments, AB 885 a State-wide issue relative to well and septic inspections, the establishment of a separate Human Resources/Risk Management department and Clerk of the Board department, the implementation of a paperless agenda, minutes and documents management system, and is very supportive of arts programs; and

WHEREAS, LEE helped contend with the impacts of damages associated with the rains in late December 2010, the Motor Fire in El Portal in 2011, the horrific Rim Fire in 2013, the many fires of 2014 known as the El Portal Fire, the Meadow Fire, the Dark Hole Fire, the Bridge Fire, and the Dog Rock Fire, and the current severe drought conditions; and

WHEREAS, LEE has performed many live portrayals of John Muir that have been enjoyed abroad by thousands, and these performances are an enlightening event for **LEE** and his wife Connie to share the concerns of John Muir for nature and the wilderness.

NOW, THEREFORE, BE IT RESOLVED that the Mariposa County Board of Supervisors, a political subdivision of the State of California, hereby recognizes, congratulates, and thanks **LEE STETSON** for his second four year term of dedication and service to Mariposa County.
