BACKGROUND AND HISTORY OF BOARD ACTIONS:

*Sb 1740 has provided weed management alliances with funding to provide Control/Management and monitoring of noxious weeds (Yellow starthistle, Klamath, etc.). A provision of the contract allows for partnerships with private and public landowners to control yellow starthistle. The contract further allows control work on Iberian Thistle on Piney Creek and continuation of the county noxious weed mapping project.*
