Adopt a resolution approving the road name "Alamo Creek Road" as a name for the subject easement taken from Lookout Mountain Road. The road name is consistent with the road naming requirements of County Resolution No. 92-54 and five of the seven property owners approve of the road name change.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board adopted Resolution No. 92-541 in 1992 establishing criteria for naming non-County roads. The road naming criteria state that road names shall be developed around some historical, botanical, zoological or geological significance. All property owners served by the road must be notified, and a majority of the responding property owners must approve of the road name request.

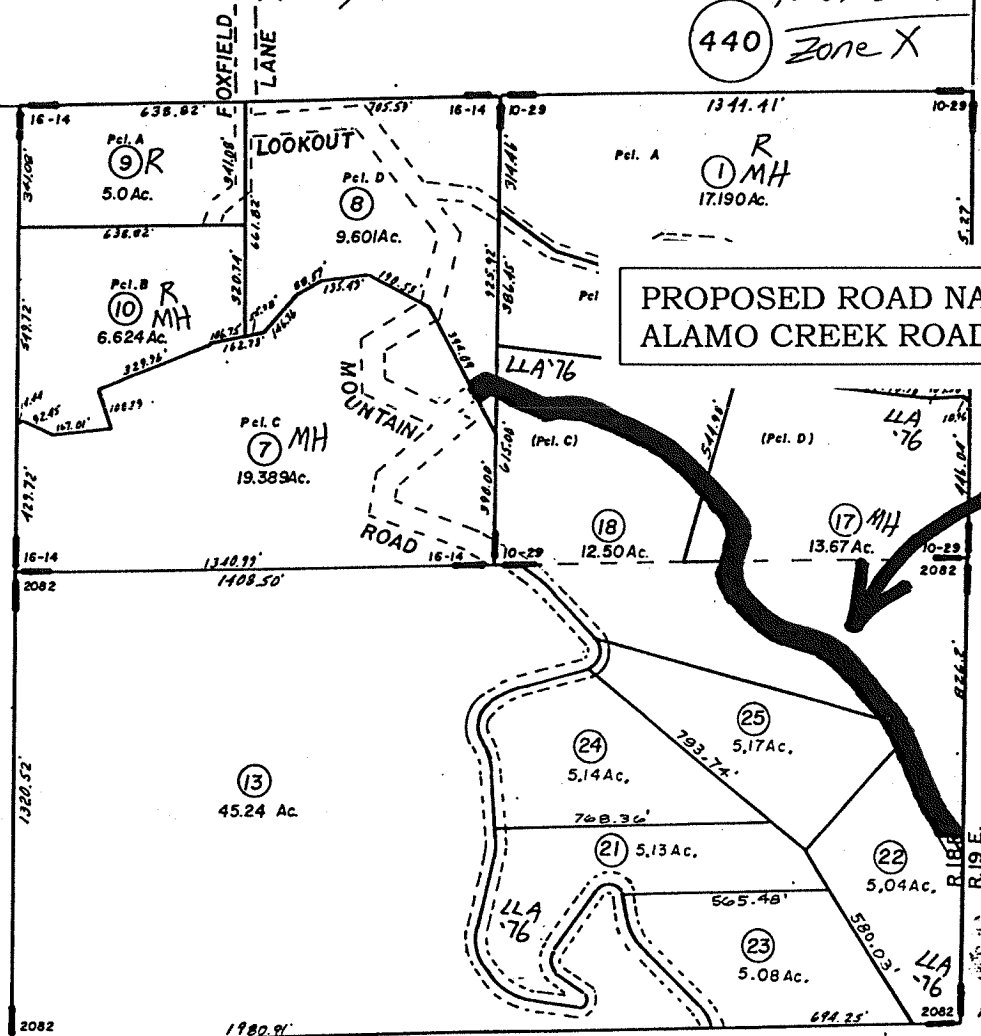

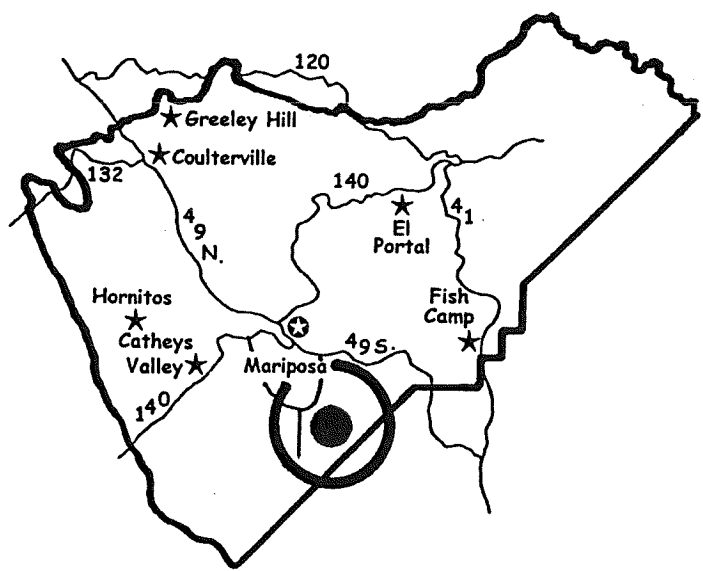
