RECOMMENDED ACTION AND JUSTIFICATION:

Waive first reading and introduce Ordinance Waive second reading and adopt Ordinance amending Section 10.08.020 of the County Code.

Public Works Department has received a request to formally establish a "No Parking" area at the Don Pedro Elementary School, on the south side of Hidalgo Street 325 feet from the intersection of Banderilla Drive, to alleviate congestion and address safety issues caused by uncontrolled parking.

Public Works staff received a copy of an accident report involving a student injury and conducted a survey of the area to determine if a problem existed and found that the uncontrolled parking was causing a potential hazard.

Funding is available in the Road Fund for the cost of signage.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board has approved similar no parking zones in the past.



MARIPOSA COUNTY ORDINANCE NO. 1044

**AN ORDINANCE AMENDING SECTION 10.08.020 ENTITLED "STOPPING,
PARKING OR STANDING PROHIBITED WHERE"
OF THE MARIPOSA COUNTY CODE**

WHEREAS, the Mariposa County Public Works Department received requests from a citizen to formally establish a No Parking area on Hidalgo Street at Banderilla Drive, and

WHEREAS, a survey of the area determined that the uncontrolled parking was causing a potential hazard.

NOW, THEREFORE, the Board of Supervisors of the County of Mariposa does ordain as follows:

SECTION I: Section 10.08.020 entitled "Stopping, parking, or standing prohibited where", shall be amended by adding Subsection "O" which shall read in its entirety as follows:

10.08.020 Stopping, parking, or standing prohibited where.


No person shall stop, park, or leave standing any vehicle, whether attended or unattended, in any of the following places:

O. The no parking zone will commence at the beginning of Hidalgo Street at the corner of Banderilla Drive. The signs are to be placed at points 400 feet from the corner of Banderilla Drive on the south side of Hidalgo Street.

SECTION II: This Ordinance shall become effective thirty (30) days after final passage pursuant to the provisions of Government Code Section 25123.
