

1 MARIPOSA COUNTY ORDINANCE NO. 803

3 AN ORDINANCE AMENDING THE MARIPOSA COUNTY ZONING MAP

4 WHEREAS, Mariposa County has received a request to amend  
5 the Mariposa County Zoning Map; and

6 WHEREAS, environmental review has been conducted on the  
7 amendment in accordance with the California Environmental  
8 Quality Act and the Mariposa County Environmental Review  
9 Policies and Procedures adopted pursuant thereto, and a Negative  
10 Declaration has been adopted for the project; and

11 WHEREAS, the Mariposa County Planning Commission and Board  
12 of Supervisors have held duly noticed public hearings on the  
13 amendment in accordance with State Law and County Code; and

14 WHEREAS, the Mariposa County Planning Commission has  
15 recommended approval of the amendment; and

16 WHEREAS, the amendment to the Zoning Map is consistent with  
17 the Mariposa County General Plan.

18 NOW THEREFORE the Mariposa County Board of Supervisors does  
19 hereby ordain as follows:

20 SECTION I

21 The properties described in Exhibit A are hereby zoned  
22 Mountain Home (MH) as provided by Chapter 17.04.030 of  
23 Mariposa County Code.

24 SECTION II

25 This action of the Board is based on the findings contained  
26 in Mariposa County Resolution No. 91-224 which is hereby

2 SECTION III

3 The Official Zoning Map of Mariposa County shall be  
4 modified to reflect that the properties described in Exhibit A  
5 are located in the zone districts as specified in Section I.

6 SECTION IV

7 This ordinance shall become effective thirty (30) days  
8 after final passage pursuant to Government Code Section 25123.




