

MARIPOSA COUNTY ORDINANCE No. 829

AN ORDINANCE AMENDING SECTION 8.36.160
ENTITLED "PERSONS AND ENTITIES PERMITTED",
TO CHAPTER 8.36 ENTITLED "SOLID WASTE DISPOSAL"
OF TITLE 8 ENTITLED "HEALTH AND SAFETY"

WHEREAS, the recent fee ordinance adopted by the Board of Supervisors of the County of Mariposa prohibits the dumping of refuse by commercial haulers in transfer stations, and

WHEREAS, subsection "C" of Section 8.36.160 entitled "Persons and entities permitted" of the Mariposa County Code is in direct conflict with this newly adopted policy, and

WHEREAS, the Board of Supervisors desires to establish a consistent policy with the implementation of this ordinance amendment;

NOW THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:

SECTION I: Section 8.36.010 entitled "Persons and entities permitted" of Chapter 8.36 entitled "Solid Waste Disposal" shall be amended by deleting subsection "C", re-lettering that Section, and adding a new subsection "D". Section 8.36.010 shall read in its entirety as follows:

"8.36.160 Persons and entities permitted.

The following person and entities are expressly permitted to dump solid waste and refuse, in compliance with the regulations of this chapter, in transfer sites and dumps in Mariposa County:

A. Residents of Mariposa County bearing identification establishing residency.

B. Owners of real property in Mariposa County bearing identification and listed on the property rolls, and their tenants, lessees and agents.

C. Persons or entities who have entered into contracts or agreements with Mariposa County for the use of dump and transfer sites. (Ord. 585 Sec.2, 1982).

D. Notwithstanding anything to the contrary contained herein, commercial refuse collectors shall not be permitted to dump or dispose of solid waste and refuse in any transfer station in the County of Mariposa."

SECTION II: This ordinance shall become effective thirty (30) days from the date of final passage, pursuant to California Government Code Section 25123.




