

1 MARIPOSA COUNTY ORDINANCE NO. 715

2 AN ORDINANCE ADOPTING THE MARIPOSA COUNTY ENVIRONMENTAL REVIEW
3 POLICIES AND PROCEDURES FOR THE PURPOSE OF IMPLEMENTING THE
4 CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) AND THE CEQA
GUIDELINES.

5 The Board of Supervisors, County of Mariposa, a
6 political subdivision of the State of California, does hereby
7 ordain as follows:

8 WHEREAS, Section 15022(a) of Title 14, Division 6,
9 Chapter 3 of the California Administrative Code requires public
10 agencies to adopt objectives, criteria and specific procedures
11 consistent with CEQA and the CEQA Guidelines for administering
12 its responsibilities under CEQA, including the orderly
13 evaluation of projects and the preparation of environmental
14 documents; and

15 WHEREAS, Mariposa County adopted comprehensive
16 Environmental Review Policies and procedures for the purpose of
17 implementing CEQA and the CEQA Guidelines within the County of
18 Mariposa, on May 13, 1986 by Resolution 86-151; and

19 WHEREAS, the Board of Supervisors has determined that
20 amendments to the Policies should be accomplished by ordinance;

21 NOW THEREFORE, this Board does hereby re-adopt the
22 Mariposa County Environmental Review Policies and Procedures for
23 the purpose of implementing CEQA and the CEQA Guidelines within
24 the County of Mariposa, copies of which are available at the


