

MARIPOSA COUNTY ORDINANCE 501

2 AN ORDINANCE AMENDING COULTERVILLE COUNTY SERVICE AREA NO. 1  
3 SEWER AND WATER ORDINANCE, MARIPOSA COUNTY ORDINANCE 484

4 The Board of Supervisors of the County of Mariposa,  
5 State of California, does hereby ordain as follows:

6 SECTION I: Article I, Section 8, Subsection I:806(a),  
7 is amended by changing the figure "\$1,010" to "\$1,737.19".

8 Article I, Section 8, Subsection I:806(b), is amended  
9 by changing the figure "\$1,010" to "\$1,737.19" and by changing the  
10 figure "\$50.50" to "\$75".

11 Article I, Section 8, Subsection I:815, Permit Optional,  
12 is amended by adding the following language so that it shall read  
13 in its entirety as follows:

14 The granting of such permission for an outside sewer in any  
15 event shall be optional with the Board; however, prior to  
16 considerations by the Board, there shall be scheduled a  
17 public hearing in the Service Area for public input on all  
18 applications for "outside sewer" contracts. The requirement  
19 for a public hearing on service connection applications for  
20 service to properties outside the Service Area shall apply  
21 on applications for water service as well as sewer service.

22 Article I, Section 8, Subsection I:826(a), is amended  
23 by changing the figure "\$17.11" to "\$21.87".

24 Article I, Section 8, Subsection I:826(b), is amended  
25 by changing the figure "\$5" to "\$6.50".

26 Article I, Section 8, Subsection I:826(c), is amended  
27 by changing the figure "\$2" to "\$3".

28 SECTION II: Article II, Section 15, Subsection II:1501,  
is amended by changing the figure "\$8.06" to "\$8.52", by changing  
the figure "73 cents" to "80 cents", and by changing the figure  
"\$560" to "\$926.67".

Article II, Section 9, Subsection II:901, is amended by changing the word "annual" to "monthly" throughout the Subsection and by adding the phrase "six-month" between the words "two installments" so that the Subsection reads as follows:


II:901. Billing Period. The regular billing period will be monthly. The monthly charge for sewer and water service may be paid in two six-month installments, one on June 1st and one on February 1st. If the charge is paid in full prior to June 1st, a discount of \$3 will be allowed.

Article II, Section 9, Subsection II:903, is amended by deleting the phrase "(February 1 and June 1)" therefrom.


SECTION III: This ordinance shall take effect immediately as an emergency measure in accordance with Government Code §25123(d) as absence of such an ordinance and the laws to implement the service area will prevent the orderly construction of critically needed sewer and water systems and, therefore, jeopardize the health and safety of the citizens and visiting public.
