

1 MARIPOSA COUNTY ORDINANCE NO. 593

2 AN ORDINANCE AMENDING TITLE 16 OF THE MARIPOSA
3 COUNTY CODE TO REQUIRE EASEMENT ROAD IDENTIFICATION SIGNS

5 The Board of Supervisors of Mariposa County does ordain as
6 follows:

7 Section I: Title 16 of the Mariposa County Code (Subdivision)
8 is amended by the addition of Section 16.12.175 and Section
9 16.20.025 as follows:

10 "16.12.175 Road Standards - Identification Signs. When an
11 easement road is named in accordance with the adopted policy
12 covering easement road naming, identification signs shall be in-
13 stalled in the following locations:

14 A. Within the subdivision's boundaries, signs shall be
15 installed at the intersection of every named easement road, County
16 Road, State Highway, or Public Road.

17 B. Any access easement which intersects a County Road, State
18 Highway, or Public Road outside of the subdivision boundaries
19 shall have an identification sign installed at said intersection.

20 All road identification signs shall be designed, constructed,
21 and installed in accordance with the standards established by the
22 County Road Department.

23 16.20.025 Streets and Roads - Identification Signs. When an
24 easement road is named in accordance with the adopted policy
25 covering easement road naming, identification signs shall be in-
26 stalled in the following locations:

27 A. Within the subdivision's boundaries, signs shall be
28 installed at the intersection of every named easement road, County

1 Road, State Highway, or Public Road.

2 B. Any access easement which intersects a County Road, State
3 Highway, or Public Road outside of the subdivision's boundaries
4 shall have an identification sign installed at said intersection.

5 All road identification signs shall be designed, constructed,
6 and installed in accordance with the standards established by
7 the County Road Department.

8 SECTION II: This Ordinance shall become effective thirty
9 (30) days from the date of final passage pursuant to Government
10 Code Section 25123.
