EXHIBIT A

BOARD OF SUPERVISORS

The Board of Administration, Public Employees' Retirement System, hereinafter referred to as Board and the BOARD OF SUPERVISORS of the COUNTY OF MARIPOSA, hereinafter referred to as Public Agency having entered into a contract under date of July 7, 1961, effective July 1, 1961, and as amended effective April 1, 1965, January 1, 1967, October 1, 1968, April 17, 1973, and April 1, 1974, and as provided by Chapters 170 and 316, Statutes of 1971, which provide for participation of Public Agency in said System, Board and Public Agency hereby agree as follows:

A. The following subparagraph shall be added to Paragraph 8 of said contract:

8 (d) Section 20021.9 (providing for classification as "county peace officers" of those employees of the Sheriff employed in county jail, detention or correctional facility and having as their primary duty and responsibility the supervision and custody of persons committed to such facility).
