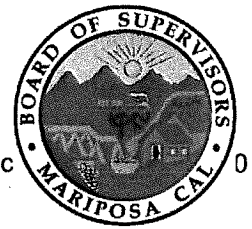

RE: Quest Community Counseling Mental Health Second Amendment
FY15/16

RECOMMENDATION AND JUSTIFICATION:

Approve a Second Amendment with Quest Community Counseling Services increasing the contract maximum by \$33,000 for a new total not-to-exceed \$133,000 to continue providing counseling services for mental health clients; and authorize the Board of Supervisors Chair to sign the Amendment.

Quest Community Counseling Services is a Medi-Cal certified provider and may provide counseling services to clients that have Medicare, Medi-Cal, and/or private insurance. Quest provides mental health counseling services by coordination with and referral from Mariposa County Behavioral Health.

The need for the services provided by Quest has been greater than anticipated; therefore, the not-to-exceed amount of the existing Agreement must be increased.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The existing agreement for this facility was approved by the Board on August 18, 2015, by Resolution Number 2015-409. A First Amendment was approved by the Board on April 19, 2016, by Resolution Number 2016-175.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

The need for the services provided by this provider has been greater than anticipated; therefore, the not-to-exceed amount of the existing Agreement must be increased in order to pay the contractor for May and June 2016 charges.

FINANCIAL IMPACT:

There is sufficient funding in the Behavioral Health budget to accommodate the requested increase in the compensation amount. There is no impact to the County General Fund.

SECOND AMENDMENT TO CONTRACT FOR SERVICES

THIS SECOND AMENDMENT TO THE CONTRACT FOR SERVICES is made and entered into this 12th day of July 2016, by and between **Mariposa County Human Services Department**, hereinafter referred to as "**COUNTY**" and **Quest Community Counseling Services**, hereinafter referred to as "**CONTRACTOR.**"

WHEREAS, COUNTY and **CONTRACTOR** have heretofore entered into an agreement dated August 18, 2015, wherein **CONTRACTOR** agreed to provide counseling services as described on Exhibit "A" of the Professional Services Agreement; and

WHEREAS, COUNTY and **CONTRACTOR** have heretofore entered into a First Amendment to that agreement dated April 19, 2016 that increased the contract maximum to \$100,000; and


WHEREAS, COUNTY and **CONTRACTOR** desire to amend said contract to change the maximum compensation to be provided to **CONTRACTOR**;

NOW, THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:


1. Paragraph 4.01 "Compensation," is hereby amended to provide that an additional Thirty-Three Thousand Dollars (\$33,000) will be added to the contract maximum of One Hundred Thousand Dollars (\$100,000), making the total compensation paid to **CONTRACTOR** the not to exceed amount of One Hundred Thirty-Three Thousand Dollars (\$133,000).
2. Except as herein amended, the agreement dated **August 18, 2015** and the First Amendment dated **April 19, 2016** shall remain in full force and effect.
