WHEREAS, it is important to the interests of the people of Mariposa County and the State of California that weighing and measuring devices be inspected regularly in Mariposa County to ensure their accuracy, and

WHEREAS, Merced County had available and is agreeable to renting the necessary equipment for the attached Weights and Measures Agreement to Mariposa on the same terms and conditions as FY 1988/89's agreement;

NOW THEREFORE, BE IT HEREBY RESOLVED by the Mariposa County Board of Supervisors that the above-mentioned Rental Agreement is hereby approved and the Chairman authorized to sign same.

HISTORY OF BOARD ACTIONS:
