

MARIPOSA COUNTY RESOLUTION NO. 88-554

A RESOLUTION CREATING AN AD HOC ADVISORY COMMITTEE FOR REVIEW OF
PROPOSED COMPREHENSIVE AMENDMENTS TO THE SUBDIVISION ORDINANCE

WHEREAS, the California Government Code sets forth
provisions for subdivisions under Section 66410 cited as the
Subdivision Map Act; and

WHEREAS, Mariposa County has adopted Ordinance no. 429, and
amendments thereto, referred to as the Subdivision Ordinance to
implement the Map Act; and

WHEREAS, the County of Mariposa has adopted various
resolutions to further implement the Subdivision Ordinance; and

WHEREAS, both the State of California and Mariposa County
have determined it is in the public interest to facilitate the
processing of applications, simplify procedures, and centralize
administration; and

WHEREAS, the Board of Supervisors has determined that a
comprehensive revision of the Subdivision Ordinance is both
necessary and desirable; and

WHEREAS, the Board of Supervisors desires to create an Ad
Hoc Advisory Committee for the purpose of reviewing proposed
drafts and preparing a report containing comments and
recommendations regarding said documents for presentation to the
Planning Commission and Board;

1 1. A committee is hereby created entitled the "Subdivision
2 Ad Hoc Advisory Committee".

3 2. The members of the Committee shall be as follows:

4 (a) One member of the Board of Supervisors.

5 (b) The Mariposa County Director of Public Works.

6 (c) The Mariposa County Counsel.

7 (d) The Mariposa County Planning Director.

8 (e) The Mariposa County Transportation Planner.

9 (f) The Mariposa County Sanitarian.

10 (g) The Mariposa County Fire Chief.

11 (h) One Mariposa County construction contractor with a
12 Class "A" license by the State of California.

13 (i) One Mariposa County surveyor licensed by the State
14 of California.

15 (j) One Mariposa County civil engineer licensed by the
16 State of California.

17 (k) One representative from the Mariposa County real
18 estate industry.

19 (l) One representative from the Mariposa Public
20 Utilities District.

21 (m) One representative of a consulting firm which has
22 completed work in Mariposa County.

23 (n) One member of the public at large.

24 4. Appointment of members designated on lines (h), (i),

7. The purpose of the committee will be to review the comprehensive amendments to the County's Subdivision Ordinance. The Committee will report to the Planning Commission and Board of Supervisors regarding their comments and recommendations.


