

MARIPOSA COUNTY RESOLUTION NO. 88-576  
COMMENDING STEVEN HICKMAN ON HIS TRANSFER TO  
JEAN LAFITTE NATIONAL HISTORICAL PARK

WHEREAS, STEVEN "STEVE" HICKMAN has served in Yosemite National Park from 9/65-1/68 and from 5/77-10/88; and

WHEREAS, STEVEN "STEVE" HICKMAN has worked at several locations in Yosemite National Park including Badger Pass, Tuolumne Meadows, Valley District, Wawona District, and the Superintendent's Office; and

WHEREAS, STEVEN "STEVE" HICKMAN has been a very positive factor in the finalization of the recently completed Memorandum of Understanding between Mariposa County and the National Park Service relating to Fire Protection and Law Enforcement; and

WHEREAS, STEVEN "STEVE" HICKMAN served as the prime National Park Service coordinator for the community cleanup of the Merced River; and

WHEREAS, STEVEN "STEVE" HICKMAN has served on numerous occasions as the Park's spokesman to the Mariposa County Board of Supervisors on very complex and on some occasions, controversial issues; and

WHEREAS, STEVEN "STEVE" HICKMAN'S participation has been instrumental in continuing the ongoing, effective relationship between the County and the National Park Service; and

WHEREAS, STEVEN "STEVE" HICKMAN'S service has been characterized by professionalism, objectivity, and thoroughness; and

WHEREAS, STEVEN "STEVE" HICKMAN is leaving Yosemite National Park to take a position as Assistant Superintendent at Jean Lafitte National Historical Park in Louisiana.

NOW THEREFORE, BE IT RESOLVED, by the Mariposa County Board of Supervisors, a political subdivision of the State of California, that STEVEN "STEVE" HICKMAN be commended by the citizens of Mariposa County for his service to residents of El Portal, Wawona District, and Yosemite National Park which has, in turn, benefitted all of Mariposa County.
