

1 MARIPOSA COUNTY RESOLUTION NO. 83-97

2 A RESOLUTION TO ADOPT THE SEVENTH ANNUAL BUTTERFLY DAYS PARADE
3 AS AN OFFICIAL MARIPOSA COUNTY ACTIVITY

4 The Board of Supervisors of Mariposa County does hereby resolve as
5 follows:

6 WHEREAS, Mariposa will hold its Seventh Annual Butterfly Days Celebration
7 with a parade on June 11, 1983, at approximately 2:00 p.m. starting at the
8 Mariposa Creek Bridge on Highway 140 and proceeding up Highway 140 and 12th
9 Street; and,

10 WHEREAS, vehicular traffic and other traffic may be diverted so as to
11 not interfere with said parade and community gathering in the town of
12 Mariposa and without inconvenience to the traveling public and the persons
13 using said highway and streets; and,

14 WHEREAS, the Board of Supervisors desires that the County of Mariposa
15 adopt the parade portion of the Butterfly Days celebration as an official
16 Mariposa County activity;

17 NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of
18 Mariposa County hereby adopts the Seventh Annual Butterfly Days Parade as an
19 official Mariposa County activity on June 11, 1983 as described hereinabove.

20 BE IT FURTHER RESOLVED that the Mariposa County Chamber of Commerce
21 shall act as the authorized agent of Mariposa County for the limited specific
22 purpose of supervising, directing, and controlling the Seventh Annual Butterfly
23 Days Parade on June 11, 1983, in the town of Mariposa, and may employ such
24 volunteers for that purpose as it shall officially designate in written notice
25 to Mariposa County; said agent is authorized to apply for permits and permis-
26 sion from other public entities as required for said parade, on behalf of
27 Mariposa County.


28 BE IT FURTHER RESOLVED that the Mariposa County Sheriff shall coordinate
