

1 MARIPOSA COUNTY RESOLUTION No. 83-124b


2 CROSSWALK ON SIXTH STREET

3 WHEREAS, it being necessary for the safety of senior citizens
4 utilizing Nutrition Site facilities on Sixth Street in Mariposa,
5 and for others parking in the upper Sixth Street parking lot;

6 NOW THEREFORE, be it hereby resolved by the Board of Super-
7 visors of Mariposa County that a crosswalk for pedestrians shall
8 be created to cross Sixth Street in the community of Mariposa,
9 between Bullion Street and State Highway 140, at a point one
10 hundred and fifty feet more or less (150'+) northeast of the east
11 corner of the intersection of Sixth Street and State Highway 140,
12 which crosswalk shall run in approximately a northwesterly direc-
13 tion acrossed Sixth Street.
