

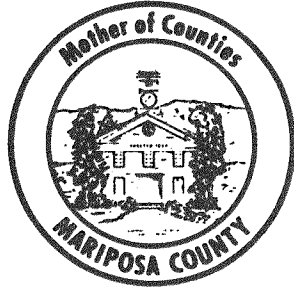

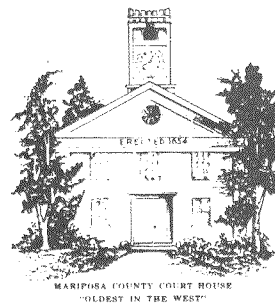

Subject: Transfer of Funds From CDF-SBA Grant  
into Workman's Compensation Fund

Dear Barbara:

I have calculated the rate for Workman's Compensation at \$9.80/\$100 in wages for the individuals working on our CDF-SBA Grant. At 40 days, I will have gross wages for the two workman at \$3,840, gross wages for a foreman and Equipment Operator at \$4,480. According to my figures that gives us \$376.32 for the two workmen and \$439.04 for the Foreman and the Equipment Operator to deposit into our Workmen's Compensation fund. The total is \$815.36.

There may be some minor changes in September because I may add two people to the workforce. I will advise you of their estimated Workman's Compensation amounts prior to their hiring.
