

1 MARIPOSA COUNTY RESOLUTION No. 82-32

2 A RESOLUTION AUTHORIZING WORKERS  
3 COMPENSATION COVERAGE FOR VOLUNTEERS  
4 IN THE SHERIFF'S AIR PATROL

5 RESOLVED by the Board of Supervisors of Mariposa County that  
6 volunteer members of the Sheriff's Air Patrol shall be covered by  
7 the Worker's Compensation coverage provided by Mariposa County to  
8 its employees under the following conditions:

9 1. Worker's Compensation coverage shall be in force  
10 only during periods of actual service at the direction of the  
11 Mariposa County Sheriff and under the control of that depart-  
12 ment.

13 2. Persons covered shall be limited to rostered mem-  
14 bers of the Sheriff's Air Patrol deputized for a specific  
15 mission or assignment.

16 3. As a condition precedent to this extension of  
17 coverage, each person to be covered shall execute a release  
18 document absolving the County of Mariposa and its officers  
19 and employees of all other liability, including damage to  
20 private airplanes and vehicles used in service, and agreeing  
21 to indemnify and hold harmless said County and employees for  
22 acts and omissions of said person causing injury, death or  
23 damage to said person, or others, or to property.

24 4. As a condition precedent to this extension of  
25 coverage, each person to be covered shall provide to the  
26 County of Mariposa a certificate of insurance with the County  
27 as additional named insured for that person's Air Patrol  
28 activities, and shall maintain such insurance in force at  
all times of service.

1 RELEASE AGREEMENT

2 MARIPOSA COUNTY SHERIFF'S AIR PATROL

3 WHEREAS the undersigned, hereinafter referred to as "MEMBER",  
4 desires to perform voluntary services for and on behalf of Mari-  
5 posa County, as a member of the Mariposa County Sheriff's Air  
6 Patrol; and

7 WHEREAS MEMBER desires to be covered by Worker's Compensation  
8 coverage as provided by Mariposa County to its officers and em-  
9 ployees;

10 NOW THEREFORE, in consideration for the Worker's Compensation  
11 coverage to be provided by Mariposa County to MEMBER during  
12 periods and times of actual service by MEMBER under the direction  
13 and control of the Mariposa County Sheriff, MEMBER agrees:

14 1. To place his name upon the roster of the Sheriff's  
15 Air Patrol;

16 2. To release, indemnify and hold harmless the County  
17 of Mariposa, its officers and employees including the Sheriff  
18 and persons employed by the Sheriff's Office, from all lia-  
19 bility other than Worker's Compensation coverage, including  
20 but not limited to:

21 a. Damage to private airplanes and vehicles used  
22 in service;

23 b. Acts and omissions of MEMBER, individually and  
24 collectively with other members, causing or resulting in  
25 death, injury or property damage to MEMBER and his prop-  
26 erty, and to other persons or property;

27 3. To provide insurance coverage for MEMBER'S own air-  
28 planes and vehicles, and to provide to the County of Mariposa
