

1 MARIPOSA COUNTY RESOLUTION NO. 82-203

2 RULES GOVERNING DISTRIBUTION OF  
3 ALCOHOLIC BEVERAGES AT COUNTY  
4 EVENTS AND ACTIVITIES

5 RESOLVED, by the Board of Supervisors of Mariposa County  
6 that the following Rules shall govern the distribution of  
7 alcohol at any activity approved and authorized by the Board  
8 of Supervisors as an official Mariposa County activity:

9 RULES

10 1. The parties, group or entity desiring to serve  
11 alcoholic beverages at any official Mariposa County activity  
12 shall be required to secure a license or permit from the  
13 California Alcoholic Beverage Control Department, and shall  
14 abide by the rules and regulations thereof.

15 2. The Mariposa County Parks and Facilities Department  
16 shall have authority to impose a curfew and such other  
17 regulations as may be found necessary to regulate the  
18 distribution of alcoholic beverages at such activity.

19 3. A Reserve Deputy of the Mariposa County Sheriff's  
20 Office, or other County officer or employee approved by the  
21 Board of Supervisors, shall be on the premises of the activity  
22 at all times during which alcoholic beverages are served, at  
23 the expense of the parties, group or entity serving alcoholic  
24 beverages, with authority to regulate the serving of alcoholic  
25 beverages pursuant to the rules set forth herein and the  
26 laws of the State of California.

27 4. Said Deputy or County Officer shall have authority  
28 to screen the identification of all persons purchasing,  
consuming or distributing alcoholic beverages.

1           5. No person, group or entity at any official activity  
2 shall furnish alcoholic beverages to any minor person.

3           6. The distribution, sale and consumption of alcoholic  
4 beverages at any official activity shall be limited  
5 exclusively to those beverages supplied by the permittee,  
6 and no other alcoholic beverage shall be brought to or  
7 distributed, sold or consumed upon the premises of the activity.

8           7. No narcotics or other illegal or controlled substance  
9 shall be permitted, distributed, sold or consumed at any  
10 official activity.

11           8. A copy of these rules shall be posted at the location  
12 of each and every official activity at which alcoholic beverages  
13 are to be consumed.

14           9. The Deputy or County Officer assigned to the official  
15 activity shall have authority to eject any person violating  
16 these rules and shall be authorized to terminate the official  
17 activity in the event of violation or misconduct by any person  
18 or failure by the permittees to cooperate or control the  
19 distribution of alcoholic beverages.

20           10. It shall be the responsibility of the person, group  
21 or entity permitted to serve alcoholic beverages at an official  
22 activity to control the distribution, sale and consumption  
23 thereof pursuant to these rules and the laws of the State  
24 of California, and to cooperate fully with County officials at


