MARIPOSA COUNTY RESOLUTION No. 82-244

AMENDING THE MEMORANDUM OF UNDERSTANDING  
BETWEEN THE COUNTY OF MARIPOSA AND THE  
MARIPOSA COUNTY PUBLIC EMPLOYEES ASSOCIATION

WHEREAS the Board of Supervisors having met and conferred  
with authorized representatives of employee organizations;

NOW THEREFORE be it hereby resolved by the Board of Supervi-  
sors of Mariposa County that the provision of the 1982-83 Memoran-  
dum of Understanding approved by the Board of Supervisors on  
September 28, 1982, is hereby further amended to add the following  
language:

"The monies credited to the County by PERS shall be distri-  
buted to the County employees in the amount of seven hundred and  
fifty dollars (\$750.00), to be divided into two equal installments  
of three hundred and seventy-five dollars (\$375.00), and paid on  
December 1, 1982, and January 3, 1983, to each person enrolled in  
PERS by Mariposa County as an employee or official of the County on  
November 23, 1982, a group of one hundred and fifty-eight persons.  
This provision is subject to adjustment if the total amount is  
subsequently changed by PERS."

The Board of Supervisors took the following action at their meeting of September 28, 1982:

"On motion of Dalton, seconded by Erickson, County employees will gain the benefit of the monies credited to the County from PERS based upon the State Legislature's act to return this money to the County and that it not exceed the amount as credited or budgeted. ADSTAIN: Taber. On motion of Dalton, seconded by Moffitt (handed page 1 to Erickson) Board approved redrafting of cost-of-living provision as amended to read that the San Francisco area Cost Price Index shall be the basis for negotiations for the annual cost-of-living salary adjustment. On motion of Dalton, seconded by Barrick, the MOU will provide for mediation of disputes by a state mediator as provided in the Government Code with parties to share costs incurred. NO: Erickson. Revisions to be incorporated as part of the MOU."
