## MARIPOSA COUNTY LAFCo NOTICE OF PROTEST HEARING

THE PURPOSE OF THIS HEARING IS TO RECEIVE WRITTEN PROTESTS PURSUANT TO GOVERNMENT CODE SECTION 57050. WHILE ORAL TESTIMONY MAY BE MADE, IT CANNOT BE CONSIDERED BY THE COMMISSION AS PART OF THIS HEARING

### **LAFCo Application No. 2022-080 for the Mariposa Town Planning Area Reorganization Project, including the Mariposa Public Utility District (MPUD) Service Area Annexation**

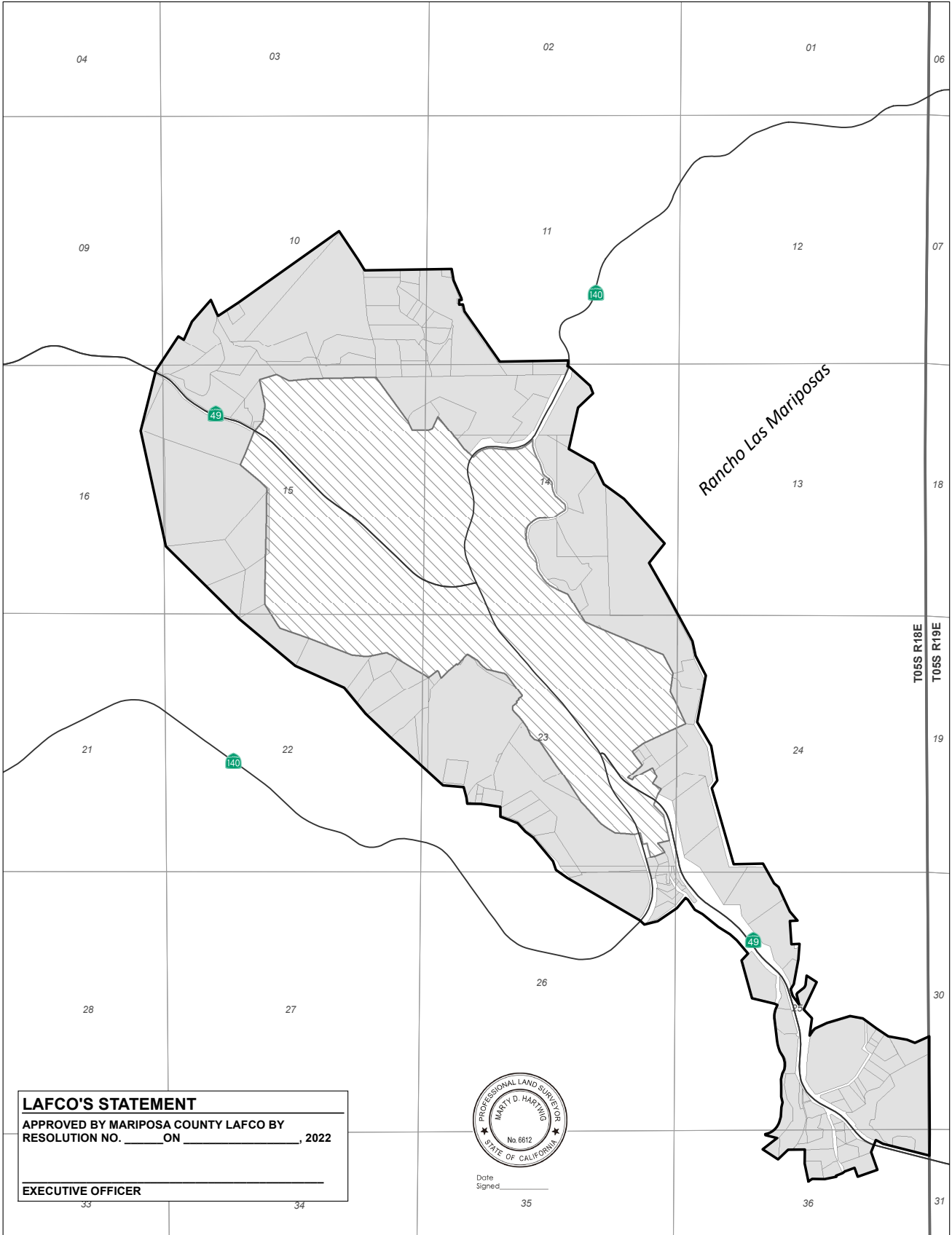
NOTICE IS HEREBY GIVEN that on June 27, 2022 at 10:00 a.m., or as soon thereafter as possible, the Mariposa County Local Agency Formation Commission (LAFCo) will conduct a public protest hearing at the Board Chambers, Mariposa Government Center at 5100 Bullion Street, Mariposa, CA 95338 to receive written protest regarding the annexation of approximately 1,636 acres to the Mariposa Public Utility District. Proceedings for this proposal were initiated by the MPUD on March 1, 2022. On May 16, 2022 Mariposa LAFCo approved the proposal subject to a protest proceeding. This annexation will only be effective upon recordation of a Certificate of Completion. You have received this notice pursuant to Government Code Section 57025 because you own property within the affected territory, you are a registered voter residing within the affected territory, or both. This hearing provides you the opportunity to file a formal written protest against the proposed annexation. A map of the territory is included on the reverse of this notice.

To be counted, protests must be in writing on Mariposa LAFCo's official protest form, a copy of which is attached to this notice for the convenience of anyone wishing to file a protest. The form may be copied or filled in and returned to the LAFCo office. Protest forms must be submitted prior to the close of the hearing. **Only forms submitted prior to the close of the hearing and signed by owners of land within the affected territory and/or by registered voters residing within the affected territory will be counted.**

Protests may be mailed to Mariposa LAFCo, at P.O. Box 2039, Mariposa, CA 95338 or delivered to the LAFCo Executive Officer or her designee prior to or at the protest hearing. Each protest must clearly state whether it is made by a landowner or a registered voter or submitted for both and must include the name and address of the person submitting it with an original signature. Landowner protests must also include a street address or Assessor's Parcel Number identifying the location of the property in question. A registered voter's protest must show the voter's name and residence address as it appears on the affidavit of registration. The value of protests received, and not withdrawn before the hearing concludes, will be determined within 30 days following the hearing in accordance with Government Code Section 57075.
